## **MATTERS ARISING:**

Letter sent to J Hayter at Clacton police station re the Exclusion Order along Broadway etc, had a reply from the local Community Sergeant saying that residents need to report incidents to enable the police to give evidence that the area needs extending. The police have found that the exclusion order is working so have asked for a time extension.

JW raised the point that after the last meeting one member felt that the meeting was a "shambles". The member stated that he had said it was very Tory biased that was why. This was explained that due to there being a new ECC councillor and a reshuffle on the Tendring District Council portfolio holders recently both councillors were Tory and that Mr Carswell was asked about attending meeting in February and July was the first he was able to attend. This was not an intentional occurrence but happened due to the new members wanting to be involved. The majority of the other members that attended felt it was a good, constructive meeting.

#### **UP DATE FROM CHAIR:**

There has been no update on Green Elms – to ask Carlo for anything he might have for next meeting. The matter was discussed regarding current information available but at present there seems to be no resolution

With reference to a letter from Stephen Foster (Environmental Officer) from the end of January stating that Tendring District Council are responsible to ensure that maintenance and clearance of the dyke is carried out. The dyke has been cleared but there is still rubbish to be collected and we need Tendring District Council to get this work completed so that the community service can keep the area clear.

#### UP DATE FROM STEVE LEE- FOSTER

SLF said he presumed everyone had seen or knew about the article in the local paper from Lord Hanningfield about Jaywick. Lord Hanningfield is heading the committee for Regeneration at Essex County Council and what he was trying to and hopefully came across was that there was not a magic wand and it was a long term plan that were needed and there would be some hard decisions to be made by county and the local council.

#### **ANY OTHER BUSINESS:**

- i. Meeting time this was discussed and agreed as the start time for the committee and local officers/councillors etc to be at 2pm and the public to be invited in from 2.30pm.

- iv. Tea/Coffee that was bought by Forum AGM agreed to pass to the Golf Green Hall as getting stale, to be used as necessary.

## **PUBLIC MEETING PORTION:**

Tamarisk Way car park bins - There are complaints from the shop and the chemist regarding lack of bins in the area and that people using the car park utilise the shop bins, which they have to pay to be emptied, to dump rubbish. Someone had put a black sack out and this was flowing everywhere the other day and looked unsightly - was said to have been placed there by the shop for people to use.

Beach Cleaning – this was discussed and is being done for 6 weeks and then hopefully, if funds available, next year, it will continue.

Brooklands Road – complaints regarding the surface and the water it retains, this was discussed and said that the drainage needs the sand clearing from it to enable the water to flow away.

Parish Council – this was discussed and a resident stated that we went through this a few years ago and why are we doing it again? The reply was because the Forum was asked about one being set up. He also raised that as we are an unusual area were we confident that the same amount of money that goes into the precept for Clacton-on-Sea would go to the Parish council in Jaywick? There was no answer available to the question as until it is looked into by the steering committee we would not be sure.

First Aiders on the beach - it was raised that there are no trained first aiders available on our beach's - to write to head of leisure and ask if we could possibly have beach patrol cover - it would not be for this year but maybe they could fund for next year, especially as our beach pulls in a lot of visitors.
