4. Nomination papers are available from the offices of the Returning Officer during the times stated above, and can be downloaded from Maldon District Council's website at [www.maldon.gov.uk](http://www.maldon.gov.uk)
5. If any election is contested, the poll will take place on **THURSDAY, 2 MAY 2019.**
6. Applications to register to vote must reach the Electoral Registration Officer, Princes Road, Maldon, Essex CM9 5DL, **by 12 midnight on Friday, 12 April 2019**, or register online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote) by the same deadline.
7. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the above address **by 5pm on Monday, 15 April 2019.**
8. Applications to vote by proxy at these elections must reach the Electoral Registration Officer **by 5pm on Wednesday, 24 April 2019.**
9. Applications to vote by emergency proxy at these elections on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer **by 5pm on Thursday, 2 May 2019.** The physical incapacity must have occurred after 5pm on Wednesday, 24 April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 24 April 2019.
